1.2 The Contractor shall provide Bosnian-Croatian-Serbian (B-H-S) language classes to American Embassy employees and their dependents to be given at a firm fixed price per session of **BAM**_____. Sessions shall be fifty (50) minutes in length and shall be scheduled between Monday and Friday 8:00 am to 6:00 pm. No more than four (4) students will be part of mutually agreed upon by the Contractor and the Government. The minimum guarantee would be one (1).

Definitions:

"COR" means Contracting Officer's Representative; see FAR 52.212-4 Contract Terms and Conditions – Commercial Items, in Section 2.

"Government" means the United States Government unless otherwise stated.

2. PERFORMANCE WORK STATEMENT

2.1. The Contractor shall provide foreign [Bosnian-Croatian-Serbian (B-H-S)] language instruction to adult students that focuses on developing language fluency at all levels of knowledge. The Contractor shall adhere to the curriculum provided by the Embassy and will assist with curriculum review and development on an as-needed basis.

The Contractor shall be available for substituting other language instructor on an as-needed basis.

Classes may range from beginner level to advanced levels.

The Contractor shall provide foreign [Bosnian- Croatian-Serbian (B-H-S)] language instruction to American Embassy personnel and, in some cases, their dependents.

For Embassy Personnel:

Instruction must focus on the acquisition of functional language skills to be used on professional fields, political and economic fields, cultural lesson, general interest, and conversational skills typically found in mass-media publications for the foreign language speaking public and to provide students with survival level language, specifically to be used in everyday situations. Instruction may take the form of role-plays, simulations and targeted functional language to be used immediately in authentic situations.

The Contractor shall develop the instruction to include the development of speaking, listening, and reading skills to enable comprehension of relevant media on a social and professional

and/or face-to-face conversation, based on identified language proficiency levels as desired outcomes. All instruction shall also include job relevant language terminology and usage of the designated field of interest. Materials provided by the students may also be used as appropriate.

For Dependents:

Instructor will use a variety of instructional techniques and materials. Instructor will provide self-produced materials for the program to fit the needs of the students. Materials provided by the students may also be used as appropriate. Specific modules should be developed to meet the needs of the students. The students should be involved in the planning of the program so that they have some input into what they most need to learn. Initially, modules will be developed which will focus on the acquisition of survival skills, such as:

- Asking for directions
- Shopping at the local market
- Getting a taxi and giving the driver an address
- Ordering in a restaurant
- Obtaining certain services, e.g. going to the dry cleaners, getting shoes repaired, getting a picture framed etc.
- Communicating with household personnel

By the end of the course students will be able to perform these skills on their own. As the students become more proficient, more advanced and sophisticated modules should be developed.

All instruction shall be based on proficiency, communication, and academic principles as used in foreign language learning institutions identified below.

- Department of State, Foreign Service Institute
- Department of Defense, Defense Language Institute

The Human Resources Office shall define the language proficiency levels identified as desired outcomes.

Based on that, the instructor:

- Assigns lessons, corrects pronunciation, structure, and usage using a variety of instructional techniques and materials
- Periodically schedules reviews and tests of subject matter to assess student's progress
- Holds initial interviews, tests aptitude and level of proficiency in order to determine appropriate level and class for students.

All students shall be measured on their language proficiency levels in accordance with the curriculum review materials. The Contractor shall administer language reviews and provide feedback to individual students and to the Human Resources Office.

2.2 Classes will be in small groups, with approximately up to four students in each group. Initial instruction will take place virtually with an option to adapt to classroom instructions, but language skills may be developed in real life authentic situations.

Classes scheduling will be the responsibility of the COR, in consultation with the contractor and the students. All efforts should be made to place students in groups of similar ability. If necessary, contractor will call to reschedule or cancel previously arranged classes. Scheduling times may not be based to cater to the personal preferences of the Contractor.

3. PERIOD OF PERFORMANCE

The period of performance for this Blanket Purchase Agreement shall be from September 2022 to September 2027.

4. CONTRACTOR FURNISHED PROPERTY

The Contractor shall provide classroom materials such as newspapers, magazines, dictionaries, or photocopied materials, written in the designated language for use by students in classroom activities.

5. GOVERNMENT-FURNISHED PROPERTY AND INFORMATION

This BPA includes the FAR Clause 52.245-11 – Government Furnished Property.

The following will be provided to the Contractor:

 - 8) VCR, Radio-Cassette Player, TV
- COPYING OF BONA FIDE TEACHING MATERIAL AND REQUIRED REPORTS MAY BE MADE ON EMBASSY COPIERS

6. **SPECIFIC TASKS** - The contractor shall provide instructional Foreign Language Training services at the firm fixed prices shown in this contract. The objectives of each training module or lesson is to prepare all students as efficiently and effectively as possible to accomplish the goals of the training for each skill level.

6.1.1. CURRICULUM REVIEWS

The Contractor will participate in any scheduled curriculum reviews to provide feedback on Embassy provided instructional materials and to suggest changes. The time spent in these review sessions will be chargeable in accordance with established prices for language classes.

6.1.2. STUDENT EVALUATION AND TESTING

The Contractor shall conduct reviews and administer tests in regular classroom sessions on knowledge and proficiency as a required element of evaluating the student's progress in the training module or lesson, in accordance with the curriculum provided by the Embassy. Feedback will be provided to all students on their progress and reports submitted to the Management Office on student participation and progress.

6.1.3. STUDENT ATTENDANCE

The Contractor shall take attendance at every class and report attendance to the designated official in the Management Office as instructed.

6.1.4. CLASS ACTIVITIES

Language class will be held with a virtual program, which we can adapt to an in-person program if/when the epidemiological situation makes it prudent to do so. Once the epidemiological situation makes it possible, occasional classes will be scheduled outside of the classroom, as called for in the curriculum, to provide opportunities for students to interact with the local population and practice their language skills. Such activities will be charged in accordance with the rates established in Section 1 on prices. The contractor will provide his/her own transportation for these activities.

6.1.5. CONTRACTOR ATTENDANCE

The contractor shall be on time for all scheduled language sessions. If the contractor is up to five minutes late for any language session, the session will be extended to ensure it lasts for 50 minutes. If the contractor is from 5 to 20 minutes late for any session, the amount payable will be half of the established price. If the contractor is more than 20 minutes late for any session, the amount payable will be zero.

6.1.6. CANCELLATION POLICY

The contractor shall use any cancelled (unattended) class that was earlier scheduled, to work on curriculum development, regardless of when the class was cancelled. The contractor shall be paid the same contracted rate for curriculum development as teaching and the Agencies shall be charged according to class schedule.

8. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

8.1. SURVEILLANCE

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

8.2 STANDARD

The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

8.3. PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(4) Any estate (other than a foreign estate, within the meaning of [26 U.S.C. 7701\(a\)\(31\)](#)); and

(5) Any trust if-

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements [26 U.S.C. 5000C](#) and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)

(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. (1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Highest-level owner means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

Immediate owner means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). 52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS—NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31));
and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.
